The state of New Mexico settled with the Vivint Solar for nearly \$2 million but that money did not go to the customers impacted.

New Mexico Attorney General Hector Balderas filed a lawsuit against Provo-based Vivint Solar, alleging that the company was defrauding customers and engaging
